SECTION 1

Executive Summary on Overall Performance

- With administrative change, all key success metrics were met or exceeded (100% 2,330%) except for "number of business advisory services" (72%). The shortfall is attributed to competition and misunderstanding of what constitutes an advisory service.
- As the Lethbridge region has a very robust entrepreneurial ecosystem, A shift to a more regional approach was undertaken in 2022-2023 and the prevalence of partnership also became a focus. Collaborative projects were undertaken and initiated with the Regional Innovation Network (RINSA), the University of Lethbridge, Lethbridge College, the BIPOC Foundation, ATB Entrepreneurial Centre, Provincial Regional Economic Development Alliances (REDAs), the Blackfoot Confederacy, Standoff Economic Development, regional Chambers of Commerce (3), Tourism Lethbridge, and Economic Development Lethbridge. Projects such as the Launch Point Pitch Competition, a Blackfoot Morphology project, Tourism Market Readiness, Scholarship Programs, and an ecosystem alignment project were either developed or executed in the 2023 fiscal year.
- A new micro loan product was introduced (FLEXLoan) to fill a gap identified through geographical limitations to the Business Improvement Loan and inquiries for smaller amounts of capital. A focus on micro loans was also initiated to supplement typical loan request amounts to diversify a marginally polarized portfolio (one corporate group encompasses approximately 20% of portfolio). CFLR has also initiated conversations with traditional banks to align key documents (business plan, cash flow, etc.) to minimize client impact during the bank decline and CFLR referral process.
